 - (vii) Faculty Members: At least two faculty members in each faculty be appointed as per the decision of the Academic Council and Board of Management already circulated to the Principals of all the affiliated Colleges of the University.
 - (viii) To make compliance and fulfillment of the conditions laid down in your affiliation letter and submit it within three months from the date of issue of this letter.
